PURPOSE OF MEETING

The purpose of the meeting was to review the style of lunch shelter, path of travel access to the new field bleachers, and fencing concerns.

ITEMS DISCUSSED

1. Principal approved the style of lunch shelter and would like to see roof color.
2. Power for lunch shelter lights may be available at light pole at base of nearby wheelchair ramp
3. Shift lunch shelter location north to align with adjacent building face to allow more space between it and the locker building.
4. Principal stated that main concern with chain link fencing is aesthetic due to age. It appears that the District is reinforcing/replacing sections of fence now. There is one area that needs review and that is the student access from the main campus through the north staff parking lot to the music room. To rectify this, a fence separating the southern row of cars from pedestrians should be installed. Refer to enclosed Eliot site plan.

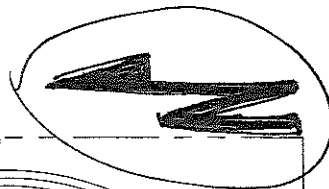

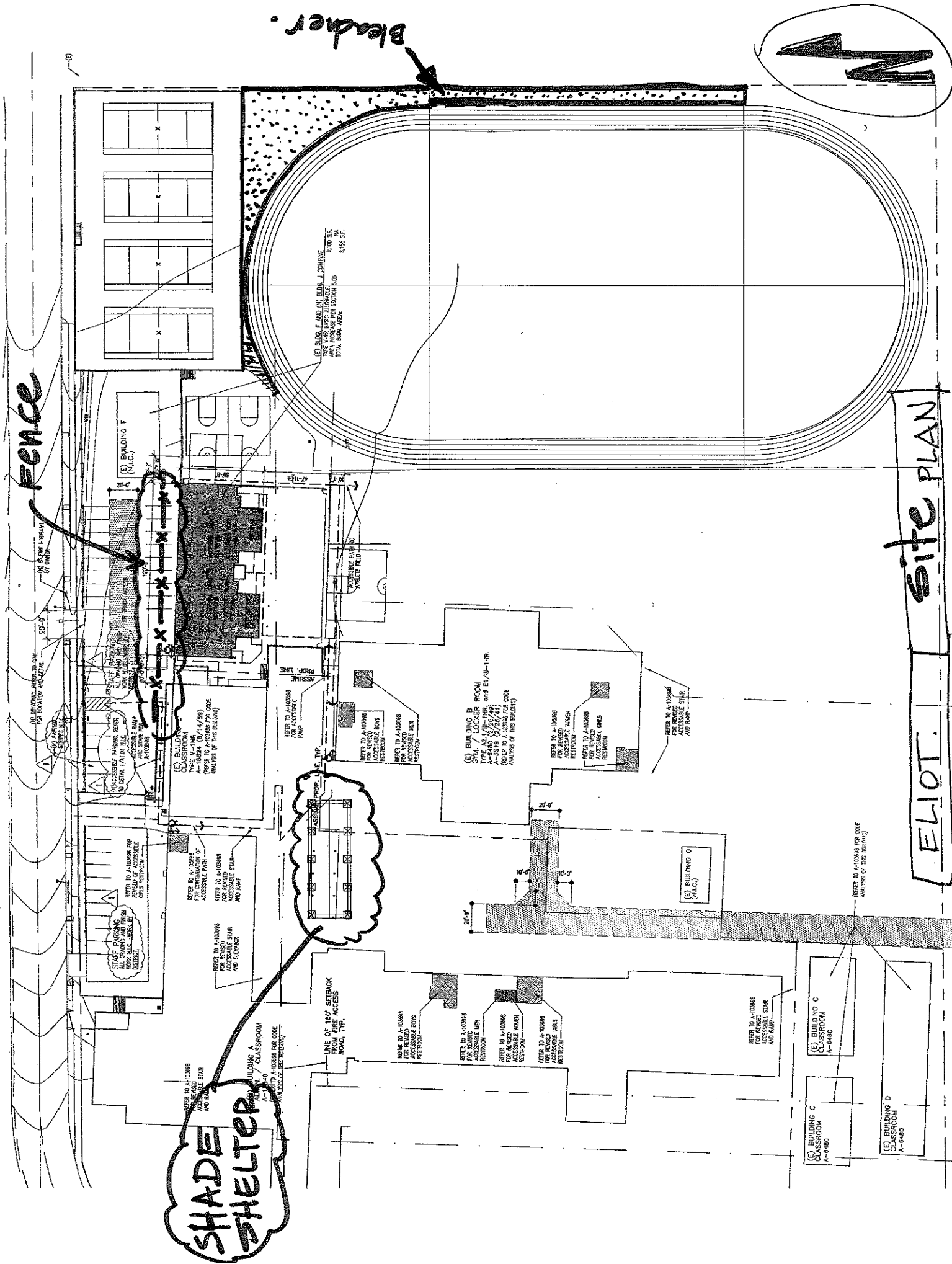
