1.01	Info	General - The meeting was held to update the Site Council on progress, and solicit feedback as appropriate, on the following campus improvements: Family Center; Playground and Kindergarten Shade Structures; Drop Off Area; Kitchen & Multipurpose Room renovation; Lunch (Courtyard) Shade Structures; Auditorium Restoration; Building A Modernization; and Window Replacement.
1.02	Info	General – These meeting minutes cover the following campus improvement areas: Auditorium Restoration; Building A Modernization; and Window Replacement.
1.03	Info	General – The next meeting with the Site Council shall be scheduled for May.
1.04	d+D	Auditorium – The general design intent, as previously documented, was reviewed for the restoration and modernization, along with an update graphics package with renderings conveying general design direction.
1.05	Info	Auditorium – Steve Brinkman confirmed that bond funding may be used for the refinishing and/or refurbishment of the existing loose wood seating on the Auditorium floor.
1.06	d+D	Auditorium – Design options for the required access ramps at the Auditorium and Building "A" main entrance were presented. The Site Council preferred the "low platforms with (irrigated) planting beds" option for each entrance. d+D will develop architectural plans reflecting this preference, using drought-resistant plantings.
1.07	d+D	Auditorium – The existing wood flooring at the main level, sloped floor and stage will be refinished as practicable.
1.08	d+D	Building A Modernization – The scope of work shall include concealing the fire sprinkler pipes in the hallways and making the overall appearance of the hallways cleaner. Bathrooms shall be upgraded to comply with current applicable codes.
