## MEETING MINUTES

November 30, 2009

Attendees: Fred Wesley, PBWS Wade Frazier, PBWS Kirstyn Perry, PBWS Steve Brinkman, PUSD Facilities Frazer Thompson, PUSD Facilities Debra Amos, PUSD Food Services

Purpose: The purpose of this meeting was to review the DD drawings including the kitchen plans provided by Laschober & Sovich.

- 1.1 Kitchen
  - A. Debra indicated that the District would prefer to have 3 speed windows if they can be accommodated in the space.
  - B. Fred noted that the doors in the kitchen sketch would not meet ADA requirements.
  - C. Debra noted that there does not seem to be enough space for two distinct lines leading to the speed windows.
    - 1. Debra asked if the court area could be more open to allow easier queing.
    - 2. Steve agreed that the student store could be relocated or eliminated to allow the court area to be enlarged.
  - D. Fred suggested that the speed line be moved north to keep it separated from the music hallway which would be more easily accommodated after the student store is relocated.

## 1.2 Multipurpose

- A. Frazer suggested that the duct distribution in the Multipurpose Room be reevaluated. He questioned the use of a single duct without any branches. PBWS will discuss this with the mechanical engineers.
- B. Frazer questioned the routing of the exhaust from the bathrooms. PBWS will discuss this with the mechanical engineers.
- C. Wade indicated that the chair storage will be located underneath the stage and that PBWS will verify size requirements for the storage carts.
- D. Steve suggested that the plans for the Multipurpose Room be sent to PUSD's theater consultant.
- E. Steve requested that PBWS discuss the stage size with Gayle Blumell & Garrett Newsom.
- F. Steve and Frazer suggested that the stage be made deeper and the music classroom sizes be reduced.
- G. Steve suggested that PBWS along with Gayle & Garrett should determine the number of people that are to be held on the stage and size it accordingly.
- 1.3 Library
  - A. Steve requested that PBWS provide and estimate of the number of volumes that can be housed in the library.

- B. Steve indicated that the stack and furniture layout seemed more like an elementary school arrangement.
- C. Wade suggested that the number of stacks be increased to accommodate more volumes.
- 1.4 Classroom Buildings
  - A. Frazer indicated that the vent stacks are not tall enough to create a temperature differential that will cause natural convection.
    - 1. Fred suggested that some mechanical assistance, such as a fan, may be required to assist the convection.
  - B. Frazer suggested that an insulated accordion door be added in the Lounge and the A/C be zoned in order to reduce the amount of area that needs to be conditioned when the room is not being used for community meetings, etc.
  - C. Steve requested the PBWS ask Gayle & Garrett if they want lockers on site or not.
  - D. Frazer questioned the proportion of the soffit in the classrooms.
    - 1. Fred suggested that the fan coil units that were to be located in the soffit be moved to the area above the workroom between the classrooms.
    - 2. Steve indicated that exposed duct work in the classrooms was acceptable.
    - 3. Frazer suggested that we avoid high flat surfaces which collect dust and dirt.
- 1.5 Gymnasium
  - A. Frazer questioned how cleaning and maintenance will be accomplished on the sawtooths.
  - B. Frazer questioned the number of branches in the gymnasium and the location of the return ducts. PBWS will discuss this with the mechanical engineer.
- 1.6 Wade will set up a meeting between Frazer, PBWS and the mechanical engineers to discuss the potential solutions and the District's concerns.
